

**Resolution 17- 6  
Budget Transfers**

**WHEREAS**, it has become necessary for the Commissioners of Fire District No. 3 in the Township of Dennis, County of Cape May, by resolution, to adopt a temporary budget to make appropriations and to provide for the period between the beginning of the fiscal year, January 1, 2018, and the adoption of the budget by the legal votes of the fire district, which election is scheduled for February 17, 2018.

**NOW, THEREFORE, BE IT RESOLVED**, by the Commissioners of the Fire District No. 3 in the Township of Dennis, County of Cape May, as follows:

- (1) A temporary budget is hereby adopted to be effective from the beginning of the fiscal year as noted above and to be in full force and effect until the adoption of the annual fire district budget to reflect not in excess of 14% of the total of the appropriations made for all purposes in the budget for the preceding fiscal year exclusive of appropriations for interest and debt redemption charges and capital improvements.
