Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 2, 2020 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2021 and ending December 31, 2021 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The 2021 Budget reflects a 2.5% increase in revenue to be raised from taxation. It includes the 2% max, all new rateables and usage of the levy cap bank from 2018. The Board has decided to increase LOSAP contributions each year in order to retain volunteers. They will also, continue to put away funds for future capital as equipment is aging and eventually will need to be replaced.

The Board is increasing the funds toward LOSAP to retain volunteers and toward future capital purchases because aging equipment will need to be replaced. The decrease in debt interest was applied to principal. All other line items remain consistent with prior year.




