WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 1, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on December 6, 2022.

The 2023 Budget reflects a 2.3% increase in revenue raised through taxation. It includes the 2% maximum and all new rateables. The increase from taxation will be used to rent and funds for future capital.

The Board is increasing line item for rent by 14.1% or \$6,400 as the fire house has taken on major projects that the Board wishes to contribute a little toward. The decrease in debt interest was applied to principal. Election expenses have increased to provide a fair wage for the poll workers. Interest income has been increased due to the fire district having more funds in Future Capital CD's and the interest rates rising.
